1. Context

- 1.1. At Ratcliffe College (referred to as the College in this document) we are informed by our Roman Catholic Rosminian ethos in all that we do.
- 1.2. In *Maxims of Christian Perfection* our founder, Blessed Antonio Rosmini, guides our lived faith as missionary disciples. We are particularly mindful that "All...are called to perfection, no matter what their state or condition may be... The perfection of the Gospel consists in the fulfilment of the two commandments of love, of God and of neighbour."
- 1.3. We agree with Bishop Marcus Stock that "The celebration of Catholic liturgies and prayers [are] an integral part of the learning and teaching [that] should enable the school community to become reflective, experience the presence of God and should develop a mature spiritual life."
- 1.4. This policy has been developed according to the guidance of the Bishops' Conference of England and Wales in *To love You more dearly: The Prayer and Liturgy Direction for Catholic Schools, Academics and Colleges in England and Wales.*
- 1.5. This policy is intended as an accessible reference point for colleagues preparing prayer and liturgy. Colleagues can consult Fr President, the Lay Chaplain or *To love You more dearly* for further specific guidance.

2. Statement of requirement

- 2.1. As an independent school, Ratcliffe College is not bound by the requirements of Section 60 of the Education Act 1988 to provide an act of daily collective worship (prayer and liturgy).
- 2.2. Nonetheless, the College recognises the guidance of the Bishops' Conference of England and Wales that "In all Catholic schools, prayer and liturgy are integral to the spiritual life of the school and to pupil' moral and spiritual development...They are integral to the Catholic identify and life of the school, and they would take place in all Catholic schools, whether or not schools were required by statue to provide collective worship."²
- 2.3. The College's provision for prayer and liturgy will fulfil pupils' entitlement to experience the range of liturgical treasures of the Church, including a shared repertoire of prayers and liturgical music with which pupils in the College will be familiar.
- 2.4. Prayer and liturgy are not designated curriculum time. In the context of Ratcliffe College, this means that times of prayer and liturgy are not considered to be part of the allocation of curriculum time for Religious Education.

3. Responsibility

3.1. **Governance**

- **3.1.1.** The governors, as guardians of the College's Catholic life and mission, have a responsibility to ensure that:
- prayer and liturgy are central to the Catholic life of the College and therefore are in line with the guidance set out by the Prayer and Liturgy Directory
- there is a named person(s) who is responsible for prayer and liturgy in the school, as a Prayer and Liturgy Coordinator. At Ratcliffe College, this is the Lay Chaplain.
- the prayer and liturgy policy is updated regularly and shared with all stakeholders
- there is a budget for prayer and liturgy that reflects its centrality to the life of Ratcliffe College as a Catholic Rosminian school.

3.2. **Headmaster**

- **3.2.1.** The Headmaster, as the spiritual leader of the College as a Catholic community, ensures that:
- prayer and liturgy are central to the Catholic life of the College and therefore are in line with the guidance set out by the Prayer and Liturgy Directory
- they work in partnership with the Lay Chaplain
- those responsible for prayer and liturgy in the College have been given appropriate training and formation to ensure that all guidance is followed and adhered to
- there are suitable resources for prayer and liturgy in the College.
- 3.2.2. With regard to the Preparatory School, the Headmaster delegates day-to-day responsibility for the above to the Headteacher of the Preparatory school.

3.3. **Lay Chaplain**

- **3.3.1.** At Ratcliffe College, this role fulfils the responsibilities of the Prayer and Liturgy Coordinator as outlined in *To love You more dearly*. The Lay Chaplain ensures that:
 - prayer and liturgy are central to the Catholic life of the College and therefore are in line with the guidance set out by the Prayer and Liturgy Directory
 - there is an Annual Plan of Provision for prayer and liturgy across the school year which identifies liturgical seasons and key celebrations, as well as opportunities for the celebration of the Sacraments
 - there is daily planned prayer for all pupils, appropriate to age and ability, as outlined in the Prayer and Liturgy Directory
 - pupils are supported in their liturgical formation to take an active role in the planning, preparation, and delivery of prayer and liturgy according to their age and capacity, and in a manner which facilitates their progressive participation
 - resources to support the planning of prayer and liturgy are appropriate and readily available to staff and pupils
 - induction on prayer and liturgy takes place for new members of staff as required
 - staff have access to effective training and formation opportunities

- monitoring and evaluation of prayer and liturgy take place regularly and feed back into planning for future liturgies
- monitoring of prayer and liturgy is reported to the headteacher and governing body to support whole-school development and the Catholic life of the College.
- there is collaboration with local clergy and parishes
- liaison with the Diocesan Advisory Service and others is maintained to ensure they keep updated with best practice.

5. Resourcing

5.1. Prayer and liturgy are central to the College's understanding of itself as a Catholic school, and this is reflected in the annual budget allocation and available resources, including staff time, chaplaincy provision, and dedicated spaces for prayer and liturgy.

- 5.2. The Catholic character of the College is reflected in religious artefacts and images on display throughout the building, most prominently the bust of our founder, Blessed Antonio Rosmini, in our Senior School Main Reception and the centrality of the Chapel of the Immaculate Conception at the heart of our campus.
- 5.3. Our dedicated spaces for prayer and liturgy will be furnished and maintained to befit their status and centrality within our College's understanding of itself as a Catholic school, and these will be updated to reflect the Church's liturgical seasons.
- 5.4. Staff training and formation costs will be funded separately to ensure that all staff are able to fulfil their responsibility to contribute to the prayer and liturgical life of the College.

6. Training and formation

- 6.1. All new staff will be supported during induction and beyond, so that they fully understand the responsibility they carry within their individual role for leading prayer and liturgy in the College.
- 6.2. Any individual training needs will be identified and addressed through training and formation.
- 6.3. There will also be the opportunity for whole-staff professional development at least once a year, so that all staff understand the importance of prayer and liturgy and relevant staff are well supported to lead as required.

7. Monitoring and evaluation

- 7.1. Monitoring and evaluation of the quality and impact of prayer and liturgy will take place regularly, and at least annually, and involve all key stakeholders: pupils, parents, staff, clergy, and governors.
- 7.2. Areas for development will be identified and issues raised will be actioned and evidenced as appropriate.

8. Review

8.1. The policy will be reviewed annually.
